# Meeting Minutes of the Argyle Public Library Board of Trustees

# 1. Call to Order

In the absence of President Jessica Martin, the meeting was called to order at 6:03 p.m. by Vice-President Bill Johnson.

### 2. Roll Call of Members

Members in attendance: Toni Harding, Monica Hodgson, Bill Johnson, Library Director Sarah Kyrie, Lynn Rossing, Also in attendance: Garry Rossing, President of the Friends of the Argyle Public Library ("Friends").

# 3. Adoption/Amendment of Agenda

Rossing moved to approve the agenda. Hodgson seconded. All in favor.

# 4. Approval of May 23, 2022 Meeting Minutes

Hodgson moved to approve the May 23, 2022 meeting minutes. Rossing seconded. All in favor.

# 6. Finances/Approval of Bills

Following up on a question from last month's meeting, Director Kyrie explained what "technology reserve" payments are. Her request for a federal Library and Science Technology Grant for the purchase of a new projector was approved. Hodgson moved to approve the bills. Rossing seconded. All in favor.

#### 7. New Business

- a. The Board discussed *Trustee Essentials: A Handbook for Wisconsin Public Library Trustees*: "Hiring a Library Director." As part of a continuity plan for the Library, Director Kyrie will start putting together an orientation program for the Library Director position and seek staff input on this.
- b. Staff Evaluations for Board members to review. Hodgson moved to discuss this topic in a closed session later in the meeting. Rossing seconded. All in favor.
- c. Old policies on website. Director Kyrie sought direction from the Board on the best way to post policies on the Library website.

# 8. Library Updates

- a. Programming:
- The Book Groups continue to be well-attended.
- The Homeschool Programs are on break for the summer.
- The Summer Reading Program. A marimba player came to Argyle on June 7. Coming up: a River Safety event with the Argyle-Adams Fire Department on June 14 at 3:00 p.m., a program at the Erickson wetlands about water health on with a story walk on June 21, and a hoop dancer at the Bob LaFollette Museum on June 28.

- Children are encouraged to track their summer reading through the end of August when they will be congratulated with a free ice cream cone at Central 52. Library staff are stockpiling books for an end-of-summer activity where children can choose a book to dedicate to the Library.
- At the June 18 Farmers Market, the Library is hosting a Thai food truck, and the Library has a variety of snacks and cookbooks available as part of a grant to bring foods from different cultures to Argyle.
- The Library recently received donations from the American Legion and Tradition Family Dentistry.
- c. Library hours. To better serve patrons, the Library is considering staying open until 7:00 p.m. (instead of 6:00 p.m.) on Mondays, Tuesdays, and Wednesdays, possibly starting next year. This item will be discussed further by the Board next month.

- c. FEH Design architect Christy Monk was the presenter at a community meeting at the EMS building on June 9. Director Kyrie shared with Board members FEH's proposal for services. Discussion followed.
